- I understand that there are inherent risks in sending my pet(s) to any activity center, such as injury or illness, and I accept these risks because they are outweighed by the benefits. I further understand that due to the way pets interact with one another, minor cuts and scratches can occur even though the pets are carefully supervised at all times.
- Island Pet Lodge agrees to exercise due and reasonable care to keep the kennel premises sanitary and property enclosed. The pet is to be fed properly and regularly, and to be housed in clean, safe quarters.
- I agree that in admitting my pet(s), Island Pet Lodge has relied upon my representation that my pet(s) is/are in good health.
- I certify that any of my pets partaking in group daycare have not harmed or shown aggressive or threatening behavior towards any other person or pets.
- Although Island Pet Lodge carefully screens all pets, occasionally they may discover this is not an appropriate environment for every pet. Island Pet Lodge reserves the right to permanently remove a pet from daycare/boarding at any time.
- I understand I am solely liable for medical care expenses and/or damages that result from injuries caused by my pet(s) while my pet(s) is/are attending daycare or boarding. I will resolve any matters directly with the Owner(s) of the other pet(s) involved based on applicable New York State Law.
- While my pet(s) is/are in the care of Island Pet Lodge, if the pet becomes seriously ill, I will be notified at once so I may inform Island Pet Lodge of measures to be taken for my pet. Island Pet Lodge reserves the right to seek immediate veterinary care if, in their opinion, my pet's health demands quick action and will notify me after my pet has been stabilized. If I am unreachable in the event of an emergency, I hereby authorize Island Pet Lodge to seek immediate veterinary care for my pet and make medical decisions on my

behalf to stabilize my pet's condition. I understand that all costs in connection with veterinary and/or other treatment shall be my responsibility.

- Every pet boarding must be up to date with heartworm/parasite/flea/tick prevention. If my pet, which is present for boarding, is found to have fleas and/or ticks, it will be bathed at my expense.
- I understand that although my pet is vaccinated, they can still get kennel cough. If my dog shows signs of kennel cough he/she will be quarantined until such time as I can pick them up and have them evaluated at my veterinarian.
- Should Island Pet Lodge need to transport my pet for any reason, I agree to indemnify and hold harmless Island Pet Lodge and waive any/all rights to file a claim against Island Pet Lodge should a motor vehicle accident occur while my pet is being transported.
- If my pet is here more than five (5) days past the scheduled pickup date without further communication; Island Pet Lodge will consider my pet abandoned and may take the pet to a local shelter or rescue group. I will be billed for all applicable fees associated with my pet's boarding and any/all surrender fees.
- I am responsible for labeling all personal belongings for my pet(s) visit at Island Pet Lodge.
- I hereby grant permission to Island Pet Lodge to use any photographs or video taken of my pet(s) in any and all publications including website entries and social media.

I certify that:

I am the legal owner of the pet(s) I am enrolling at the Island Pet Lodge.

To the best of my knowledge, my pet(s) has/have not been exposed to kennel cough, distemper, rabies or parvovirus within the last thirty (30) days.

My pet is up to date on all core vaccinations (Rabies, Distemper, Kennel Cough, Parvo) and has had a Negative Fecal Test within 1 year and annually thereafter.

All information on my pet(s) profile is accurate and I will provide updated vaccination records for my pet(s) annually or upon request of Island Pet Lodge.

By signing this document, it shall be binding upon both parties for current and all future daycare and/or boarding visits and this is the entire agreement between the parties.
